The Department for Self Reliance and Navajo Family Assistance Services hours during the Navajo Nation Government Closure

Window Rock, Ariz. - On Friday, November 13, 2020, Navajo Nation President Jonathan Nez and Vice President Myron Lizer reissued a Stay at Home (Shelter in Place) Lockdown Order for three consecutive weeks from Nov. 16 through Dec. 6, 2020, and the Navajo Nation Public Health State of Emergency Declaration – declaring “Red Status” for businesses.

The Department for Self Reliance (DSR) and the Navajo Family Assistance Services (NFAS) programs are considered essential, therefore, the DSR will continue to provide all need-based programs throughout the lockdown.

DSR/NFAS is a business, therefore, all DSR/NFAS locations will be open Monday through Friday, from 8:00 a.m. to 3:00 p.m. to answer phone calls, respond to e-mail, and accept documents and applications via drop boxes. DSR / NFAS Customers, applicants, and the public will not be allowed access to DSR offices.

All DSR services are need-based programs that require an application to determine eligibility for assistance. To request an application for any of the following services: Temporary Assistance for Needy Families (TANF), Burial Assistance, Low-Income Home Energy Assistance Program (LIHEAP), General Assistance (GA), Community Services Block Grant (CSBG).

Applications and documents may be scanned and e-mailed, or mailed. Drop boxes are available at each DSR office during business hours. Call the DSR office to alert them you are dropping off documents.
